Ethiopia at crossroad

Prime Minister Abyi Ahmed was sworn in on 4 October 2021 for a five-year term as Ethiopia's new leader. This reappointment comes in a tense political context, where Tigray has been ravaged by violent fighting since November 2020. Since the beginning of the fighting, the war has killed more than thousands people and forced more than 1.7 million to flee their homes. For those who have remained in the region, the humanitarian toll is dramatic: some 400,000 people are living in famine conditions, with humanitarian aid still struggling to arrive. According to the Ethiopian Human Rights Commission (EHRC) and UN OHCHR joint investigation report, all parties to the conflict continue to be implicated in allegations of human rights violations.

Ethiopia's multifaceted challenges require a nuanced understanding of the last 30 years' political evolution. In order to understand the current situation, Members of the European Parliament Michèle Rivasi and Jan-Christoph Oetjen invite key speakers to discuss the origin of the conflict, the security situation and the role of the international community and the consequences of the conflict. This conference will be an opportunity to have a better understanding of this country in conflict and to exchange on the role of the West in the peace process.
